Comm. Cullen recused himself from the discussion concerning the MVCA Field/Facility Impact.

MVCA FIELD/FACILITY IMPACT -

Attorney Jansen reviewed his advice from the April 12, 2006 Work Session. Attorney Jansen stated that the position he has taken from the very beginning is that the Township Committee has the ability to decide what is the minimum percentage that would be acceptable to the municipality in any specification or request for quotation that they initiate. There are a number of variable factors which could be taken into account. When the Township has solicited quotations, it has established a minimum percentage figure. The competition comes from people bidding up that percentage. If the specified minimum was 20% and we have three entities who want to run that particular camp, someone could offer to return 25% to the Township and somebody else could offer to return 30%.

Mr. Jansen stated that it is too late to get involved in the formal solicitation of bids or competitive contracting for this particular camp or clinic for this year. We have to arrive at a number for this year that everyone feels is fair. We also need to take into account that the MVCA has already started to register people for this year and people are counting on the operation.

The Township Committee discussed the MVCA 10 week Summer Camp program and the fee to be charged for 2006.
