DISCUSSION

ECONOMIC DEVELOPMENT COMMITTEE REBIRTH - Mayor Walsh proposed that the Committee reintroduce the Economic Development team and have it initially comprised of two members of the Planning Board, two members of the Downtown Revitalization Committee, two members of the Village Association, and a couple of people with economic development experience; one of whom would be Assemblyman Guy Gregg who has expressed interest in helping with this venture. Mayor Walsh stated that his goal is to have a non-funded organization that looks at how to attract new business, how to pursue downtown revitalization, how to market Long Valley as a destination, etc. Mayor Walsh further stated that between now and December 31, 2007, a mission statement will be developed with suggestions to pursue the same. He would also like recommendations as to rezoning and tax adjustments. Mayor Walsh opined that he would like this committee to be serious about its commission. Comm. Cullen agreed that the idea is sound. Comm. Short is concerned with its encroachment on the Highlands Act and redundant committees. Comm. Tobin stated that he liked the idea as long as the committee was working toward more commercial ratables. Comm. Nedd also liked the idea with some emphasis placed on filling up existing vacant commercial space in town. Mayor Walsh stated that an initial focus of this committee should be the vacant Cooper Chemical Plant, which currently owes approximately \$1.5 million in back taxes.

Mayor Walsh opened the meeting to the public. There being no comments or questions, Mayor Walsh closed the meeting to the public.

<u>COMMUNITY CENTER</u> - Comm. Cullen inquired about the Community Center. Comm. Short stated that they are waiting on money for engineering from U.S. Homes. U.S. Homes is currently before the Planning Board with another set of plans.

FORESTRY GRANT – Comm. Tobin noted that Washington Township was turned down for the Forestry Grant application as the plea was weak. He would like an inquiry as to what was weak about the proposal.
