Title or Subject: AUTHORIZE THE EXECUTION OF THE FIRST RENEWAL INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WASHINGTON AND THE BOROUGH OF CALIFON FOR A SHARED MUNICIPAL COURT

WHEREAS, the Township of Washington, County of Morris and the Borough of Califon, County of Hunterdon desire to enter into a renewal agreement for a shared municipal court located in the Township of Washington; and

WHEREAS, municipalities are permitted to enter into such agreements pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 *et seq.* and N.J.S.A. 2B:12-1.c.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Washington, in the County of Morris and State of New Jersey, as follows:

1. That the Mayor and the Acting Municipal Clerk are hereby authorized to execute the First Renewal Interlocal Services Agreement between the Township of Washington, County of Morris, and the Borough of Califon, County of Hunterdon, for a shared municipal court for a term to commence on June 1, 2008 and to terminate on December 31, 2009.
2. A copy of the Agreement is on file in the office of the Township Clerk for inspection by the public.
3. This resolution shall take effect immediately.
