Personnel Discussion.

The opinion of the subcommittee, formed after the January 20, 2014 Regular Meeting, is that there appears to be a conflict of interest as defined in the Local Government ethics statutes. The recommendations of the subcommittee are: to consider modifying the Township Nepotism Policy, to adopt a uniform job application where familial relationships will be disclosed, to transfer **Ruth Spae** to a department where she will not be supervised by a family member and to revise her job responsibilities and reduce her hours to 24.5 each week effective March 3, 2014, to retain a copy of the interoffice memo read by **Mayor Short** in **Mr. Ruggiero's** personnel file, and to authorize up to 10 hours each week for a part time inspector in the Building Department.

<u>Attorney Scirocco</u>, legal council for **Mr. Ruggiero**, asked if any punitive actions will be taken against **Mr. Ruggiero**. **Mayor Short** stated there would not be.

Attorney Mc Briar, legal council for Ms. Spae, asked for clarification on Ms. Spae's change in employment. Mayor Short stated that the position would go from full time to part time, 24.5 hours each week. Ms. Spae would be under the supervision of the Zoning Office. Attorney Mc Briar requested an employee hearing.

Steven Trimboli, Labor Attorney for Washington Township directed Ms. Spae to the grievance procedures outlined in the Township Employee Manual.

Attorney McBriar and Attorney Sirocco received a copy of the interoffice memo Mayor Short read at the meeting containing the subcommittee's findings.
