<u>**DPW – Promotion.**</u> The Committee decided to defer consideration of a promotion until the summer after a retirement is expected to be announced.

<u>Animal Census</u>. Approximately 25% of the census needs to be completed. <u>Administrator Coppola</u> suggested completing the census then conducting a periodic review to make sure residents continue to license their animals. The census would be funded by the Animal Trust, overseen by a Municipal Employee and the census takers would be temporary part time workers. If approved, the project would begin in June. The Committee directed <u>Administrator</u> <u>Coppola</u> to proceed with the census.

<u>Trails.</u> <u>Mayor Roehrich</u> and <u>Vice Mayor Short</u> met with the Chairman of the Open Space Committee and learned that funds will be available to assist towns in building trails to access open space. The Open Space Committee suggested a list of projects be developed. The use of an Ad Hoc Committee is being considered. Comm. LiaBraaten suggested that Scouts be represented on the Ad Hoc Committee. Mayor Roehrich suggested that the Recreation, Environmental, and Open Space Committees also be represented on the Ad Hoc Committee.

Attorney Jansen stated that the Committee does not intend to come out of Executive Session and take any action.
