**Recycling Center Hours**. **Administrator Coppola** was directed to conduct a survey of recycling center hours and the volume of traffic. Once that information is compiled, the Committee will discuss the possibility of reducing recycling center hours. **Comm. Babb** suggested more of a self-serve Recycling Center, thus reducing the need for manpower.

<u>Temporary Part Time Tax Office Help.</u> <u>Administrator Coppola</u> reported that five candidates were interviewed for the temporary position. A candidate has been selected. Two existing part-time employees will work additional hours to assist in office coverage during the upcoming maternity leave. An Appointments Resolution will be voted upon later tonight.
