Title or Subject: WASHINGTON TOWNSHIP COMMUNITY EVENTS ORGANIZATION
TEMPORARY CLOSURE OF ROADWAYS FOR THE 275TH ANNIVERSARY
PARADE

WHEREAS, the Township Committee of the Township of Washington approved Resolution No. R-119-13 on August 19, 2013, which resolution authorized the closure of a portion of East Mill/West Mill Road to vehicular traffic between the hours of 3:30 pm and 5:00 pm on Saturday, September 21, 2013 in order to conduct the parade portion of the 275th Parade and Fireworks Festival in Washington Township; and

WHEREAS, the Washington Township Community Events Organization has requested the closure of an additional portion of East Mill Road and the closure of a portion of Old Farmers Road, all of Carl Lane, a portion of Valley View Road and a portion of Long Valley Boulevard for parade staging purposes; and

WHEREAS, N.J.S.A. 39:4-8c (6) allows a municipality to approve street closings by resolution and without the approval of the commissioner for periods up to 48 consecutive hours.

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Washington, County of Morris, State of New Jersey as follows:

1. The following roads and/or portions of roads shall be closed to vehicular traffic between the hours of 3:30 pm and 5:00 pm on Saturday, September 21, 2013 for parade purposes.

a) The portion of East Mill/West Mill Road from just west of the intersection of North Washington Valley Road to the Long Valley Middle School;

b) The portion of Old Farmers Road from its intersection with East Mill Road to its intersection with Long Valley Boulevard;

c) Long Valley Boulevard from its intersection with Old Farmers Road to its intersection with Valley View Road;

d) Valley View Road from its intersection with Long Valley Boulevard to Carl Lane; and

e) All of Carl Lane.

2. Vehicles participating in the parade shall be allowed to use the above referenced roadways.

3. Roadways or portions of roadways shall be re-opened to vehicular traffic as soon as possible after the parade passes but not until the Police Department determines that it is safe to do so.

4. This resolution shall supersede Resolution No. R-119-13.

5. This resolution shall take effect immediately.
