

**RO-01-13**

**AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF MORRIS, AND STATE OF NEW JERSEY NAMING A CERTAIN STREET/ROADWAY FOR A MILITARY HERO AND RECOGNIZING THE NAMING OF OTHER PRIVATE STREETS/ROADWAYS FOR MILITARY HEROES**

**WHEREAS**, the American Veterans Association, Post 1776, of Washington Township, ("Post 1776"), has requested that the Township honor three heroes of the Township who gave the ultimate sacrifice of their lives for their country during wartime by naming certain streets and by-ways in the Township with the names of these heroes; and

**WHEREAS**, the Township Committee is desirous of so naming a street/roadway over which it has jurisdiction and supporting the renaming of other roadways over which it does not have jurisdiction.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Washington, in the County of Morris, and State of New Jersey, as follows:

**SECTION 1.** The entry road to the Senior Center/Veterans monument area of Rock Spring Park is hereby designated as "James 'Jamie' Smith Road" in memory of James 'Jamie' Smith, United States Army, 25th Infantry Division, 27th Infantry Regiment, Killed in Action, Somalia, 2 October 1993 and the installation of an appropriate roadway sign is hereby authorized.

**SECTION 2.** The Township hereby supports the naming of the entry road to the Califon Road Cemetery, a privately-owned property, as "John L. Lindaberry Lane" in memory of John L. Lindaberry, United States Army, 25th Infantry Division, 27th Infantry Regiment, Killed in Action, Vietnam, 16 November 1967.

**SECTION 3.** The Township hereby supports the naming of both the entry and access to the parking area of Zion Lutheran Church, Long Valley, a privately-owned property, in memory of Vincent E. Fields, United State Marine Corps, 4th Division, 25th Infantry Regiment, Killed in Action, Iwo Jima, 6 March 1945.

**SECTION 4.** All ordinances of the Township of Washington, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 5.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 6.** This Ordinance shall take effect as required by law.
