<u>MAYORS UPDATE</u> – the Township Committee has spent the past six weeks working on the budget. The difficult winter stressed the DPW budget because of overtime and salt usage. More roads are now in bad shape. There will be a 2.9% budget increase this year; this calculates to an average increase of \$55 per household, \$40 of this increase is related to DPW winter expenses.

JCP&L has experienced only three minor outages this season. This improvement shows that the utility has been proactive.

2,500 residences have registered with Nixle, which is 38% of the Township. Mayor Short encouraged anyone who has not registered their cell number or email address to please do so.

Today the Senior St. Patrick Day Luncheon took place at the Senior Center. Approximately 60 seniors attended. Girl Scouts and the Junior Women's Club assisted Washington Township staff.
