Title or Subject: AUTHORIZE THE RENEWAL OF THE INTERLOCAL SERVICES AGREEMENT FOR THE SHARED SERVICES OF A CHIEF FINANCIAL OFFICER BETWEEN THE TOWNSHIP OF WASHINGTON AND THE TOWNSHIP OF CHESTER

WHEREAS, the Township of Washington, County of Morris and the Township of Chester, County of Morris, entered into an agreement for the shared services of the licensed, qualified Chief Financial Officer of the Township of Washington, as required by N.J.S.A. 40A:9-140.1 et seq.; and

WHEREAS, municipalities are permitted to enter into such agreements pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq.

WHEREAS, the Township of Washington and the Township of Chester desire to renew the agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Washington, in the County of Morris and State of New Jersey, as follows:

1. The Mayor and the Township Clerk are hereby authorized to execute a renewal Interlocal Services Agreement between the Township of Washington, County of Morris, and the Township of Chester, County of Morris, for the shared services of the licensed, qualified Chief Financial Officer of the Township of Washington for a term to commence on January 1, 2013 and to terminate on December 31, 2013.
2. A copy of the agreement is on file in the office of the Township Clerk for inspection by the public.
3. A copy of the agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
4. This resolution shall take effect immediately.
