**Title or Subject: AUTHORIZE THE EXECUTION OF AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF WASHINGTON AND THE BOROUGH OF CALIFON TO PROVIDE ANIMAL CONTROL SERVICES TO THE BOROUGH OF CALIFON**

**WHEREAS**, the Township of Washington, County of Morris and the Borough of Califon, County of Hunterdon, desire to enter into an agreement to provide animal control services to the Borough of Califon; and

**WHEREAS**, municipalities are permitted to enter into such agreements pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Washington, in the County of Morris and State of New Jersey, as follows:

1. That the Mayor and the Municipal Clerk are hereby authorized to execute an Interlocal Services Agreement between the Township of Washington, County of Morris, and the Borough of Califon, County of Hunterdon, for shared animal control services for a term to commence on January 1, 2013 and to terminate on December 31, 2013.
2. A copy of the agreement is on file in the office of the Township Clerk for inspection by the public.
3. A copy of the agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
4. This resolution shall take effect immediately.
