

# RESOLUTION OF THE TOWNSHIP OF WASHINGTON

**Title or Subject: AUTHORIZATION FOR SALE OF CERTAIN PERSONAL PROPERTY**

**WHEREAS**, the Township of Washington has in its possession certain personal property; and

**WHEREAS**, the Township of Washington has determined that personal property as described in Schedule A is no longer needed for public use; and

**WHEREAS**, the Department of Community Affairs of the State of New Jersey permits the sale of surplus property no longer needed for public use through the use of on-line auction services pursuant to the Local Unit Electronic Technology Pilot Program and Study Act, P.L.2001,c.30; and

**WHEREAS**, the Township of Washington desires to sell the property listed on Schedule A on-line.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Washington, County of Morris, State of New Jersey, as follows:

1. The attached schedule of Township property is hereby declared surplus and is no longer needed for public purposes.
2. All personal property on the attached schedule shall be listed for sale on GovDeals.com from April 29, 2013 through May 8, 2013.
3. Payment in full is due not later than 5 business days from the time and date of the Buyers Certificate.
4. Acceptable forms of payment are Cash (U.S. Currency), Certified Check or Money Order and shall be made payable to the Township of Washington. Payment must be sent to Kevin Lifer, Township of Washington, 43 Schooley's Mountain Road, Long Valley, New Jersey 07853, 908-876-3315.
5. The successful bidders must remove items within 10 business days from the time and date of issuance of the Buyers Certificate. Purchases will be released only upon receipt of payment as specified.
6. Successful bidders are responsible for the loading and removal of any and all property awarded to them from the place where the property is located as indicated on the website and in the Buyers Certificate.
7. The Buyer will make all arrangements and perform all work necessary, including packing, loading and transportation of the property. Under no circumstances will the Township of Washington assume responsibility for packing, loading or shipping.

8. Property may be removed between the hours of 8:30 A.M. and 3:00 P.M. Monday through Friday, excluding legal holidays.
9. The public may view the listed items at the Washington Township Department of Public Works, 54 Rock Road, Long Valley, New Jersey between the hours of 9:00 A.M. to 2:00 P.M. during the 11-day auction period. The Township of Washington reserves the right to withdraw any listed items from the sale or to set minimum bid prices.
