1. <u>Enclave (Regency</u>) – Block 28, Lot 46.45 – 2 Raspberry Lane – Soil Disturbance Permit Application Representatives present: Attorney Michael Selvaggi, Robert Miller (Toll Brothers)

Mr. Akin recused himself from hearing this application due to a conflict of interest. Engineer Hall referred to his 1-25-16 report. The applicant stated that 4000 cubic yards of fill are being exported from the site and that this will amount to 270 truckloads. The Board was informed that the trucks will not be travelling up Schooley's Mountain Road. Engineer Hall recommended that the trucks travel making a left onto Fairview Avenue and then turn left onto Schooley's Mountain Road and right onto East Mill Road and then left onto Bartley Road. Mr. Hall recommended that trucking times be limited to 8:30 a.m. to 4:30 p.m. The applicant had no problem with this recommendation. Engineer Hall stated that before work commences, the applicant will have to submit checks for \$4000 for a performance guarantee and \$5000 for the inspection escrow.

A motion was made by <u>Mr. DiSalvo</u>, seconded by Mr. <u>Read</u> to grant approval of the soil disturbance permit application for Enclave with the modified truck route, the allowable truck time of 8:30 a.m. to 4:30 p.m., and the submission of the \$4000 for a performance guarantee and \$5000 for the inspection escrow prior to work commencing. Mr. Akin rejoined the Board.

 <u>Township of Washington/Fraser Properties</u> – Block 18, lot 10.01 – Coleman's Road -Minor Subdivision - Completeness Determination & Public Hearing Representatives present: Andrew Coppola, Township Administrator, William Hollows, P.E.

Mr. Coppola and Mr. Hollows were sworn-in. Mr. Coppola stated that Washington Township has applied for a 10 ½ acre lot grant to use the new subdivision lot as open space. The proposed use is for fishing, picnicking, and other uses of the existing pond. Engineer Bill Hollows stated that the existing lot is Block 18, Lot 10.01 which fronts on both Route 24 and Coleman's Road. The Fraser's specialty garage lot will contain 1.18 acres (51,555 square feet) of area, and the new Township lot will contain 447,472 square feet of area. Mr. Hollows stated that variances for lot area, lot coverage, lot width and rear yard setback have been requested. He stated that the required lot area in the R-5 Zone is 200,000 square feet and the Fraser lot will only have 51,555 square feet of area. He stated that the required rear yard setback in the R-5 Zone is 100 feet for the principal building and 73.4 feet is being proposed. Mr. Hollows stated that the Fraser lot will have .2% lot coverage, which exceeds the maximum allowable lot coverage of 25%. Mr. Hollows stated that the Fraser lot width and the Fraser lot width in the R-5 Zone is 300 feet. It was noted that no new development is proposed for either lot.

Engineer Hall noted that the following design waivers will be needed for this application; 1. the minor subdivision plat needs to have the sight easement shown on it, 2. a drainage and/or conservation easement has not been shown, 3. a 50 foot wide rural road buffer has not been provided, and 4.a rounded

block corner has not been provided. Engineer Hall stated that he would recommend the granting of all four waivers.

A motion was made by <u>Mr. DiSalvo</u>, seconded by <u>Mr. Popper</u> to grant approval of the minor subdivision to the Township of Washington and Fraser properties including approval of the noted variances and design waivers. A roll call vote was taken and the motion carried.
