15-14 <u>Sam Barsa</u> – Block 33, Lot 6 – Schooley's Mountain Road – R-5 Zone – Two lot minor subdivision with variances for flag lot staff, lot area, rear yard setback and 2-1 slope – Extension granted through August 31, 2015

APPLICATIONS & DISCUSSION

1. <u>Long Valley Gas</u> – Block 35.01, Lot 32 – 69 East Mill Road – C-1 Zone - .92 Acres – Amended Preliminary & Final Site Plan Application for an Existing Free Standing Sign Replacement

It was announced that the LED sign had been replaced with the previously approved non-LED sign. Engineer Hall noted that when the canopy had been built the applicant had received a temporary Certificate of Occupancy and that several unaddressed items from the resolution of approval needed to be addressed. The Board directed the Secretary to send a letter notifying Long Valley Gas of all unaddressed resolution items.

DISCUSSION/CORRESPONDENCE

1. Proposed Ordinance - Amendment to §217-118, Review Fees - Planning Board Review

The Board reviewed the fee ordinance amendment which is going for second reading by the Township Committee. A motion was made by <u>Mr. DiSalvo</u>, seconded by <u>Mr. Leavens</u> to state for the record that the proposed ordinance amendment is not inconsistent with the Township Master Plan or the Township Zoning Ordinance. 2. Township Committee Authorization to the Planning Board to Undertake a preliminary Investigation and to conduct a public hearing to determine whether the 60 ft. wide private Right-of-way known as Esna Drive is a Redevelopment are according to the definitions and criteria set forth in the Local Redevelopment and Housing Law

Attorney Cofoni stated that the Planning Board is now being charged with undertaking a preliminary investigation and conduct a public hearing to determine whether Esna Drive is a redevelopment area. She said that the process is similar to the process that the Board went through for Block 30, Lots 70, 70.01, 70.02 and 71.03.

Planner Banisch stated that the Board will be having a public hearing on this matter at its September 14th meeting. Engineer Hall noted that an access easement exists for Esna Drive and that there are two property owners that are to be noticed for this hearing.

3. Housing Plan Element and Fair Share Plan

Planner Banisch gave a brief review of the status of Washington Township's Declaratory Judgement which was filed with the court in July. He noted that Washington Township has 5 months from the filing date in which they have immunity and that the Township needs to seriously consider the impact of its affordable housing obligation and develop a plan. Mr. Banisch noted that this matter will be on the agenda for the September 14th meeting.

4. Vouchers

<u>Mr. Leavens</u> made a motion to approve the vouchers reviewed by the Chairman and found in order and send them on for payment, seconded by <u>Mr. DiSalvo</u>. A voice vote was taken; all were in favor and the motion carried.

<u>Mr. Bauerlein</u> made a motion to adjourn, seconded by <u>Mr. DiSalvo</u>. A voice vote was taken; all were in favor and the meeting was adjourned at 8:20 p.m.
