Title or Subject: **AUTHORIZATION FOR SALE OF CERTAIN PERSONAL PROPERTY**

WHEREAS, the Township of Washington has in its possession certain personal property; and

WHEREAS, the Township of Washington has determined that the personal property described on Schedule A is no longer needed for public use; and

WHEREAS, the Department of Community Affairs of the State of New Jersey permits the sale of surplus property no longer needed for public use through the use of on-line auction services pursuant to the Local Unit Electronic Technology Pilot Program and Study Act, P.L.2001,c.30; and

WHEREAS, the Township of Washington desires to sell the property listed on Schedule A on-line.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Washington, County of Morris, State of New Jersey, as follows:

1. The items on the attached schedule of Township property are hereby declared surplus and are no longer needed for public purposes.
2. All personal property on the attached schedule shall be listed for sale on GovDeals.com from April 6, 2026 through April 16, 2026
3. Payment in full is due not later than five business days from the time and date of the Buyers Certificate.
4. Payment **must** be made electronically through the GovDeals website.
5. The successful bidders must remove items within 10 business days from the time and date of issuance of the Buyers Certificate. Purchases will be released only upon receipt of payment as specified.
6. Successful bidders are responsible for the loading and removal of any and all property awarded to them from the place where the property is located as indicated on the website and in the Buyers Certificate.
7. The Buyer will make all arrangements and perform all work necessary, including packing, loading and transportation of the property. Under no circumstances will the Township of Washington assume responsibility for packing, loading or shipping.
8. Property may be removed between the hours of 8:30 A.M. and 2:30 P.M. Monday through Friday, excluding legal holidays.
 9. The public may view the listed items at the Washington Township Department of Public Works, 54 Rock Road, Long Valley, New Jersey between the hours of 8:30 A.M. to 2:30 P.M. during the 11-day auction period. The Township of Washington reserves the right to withdraw any listed items from the sale or to set minimum bid prices.
