

ORDINANCE No. RO-09-26

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 203 “VEHICLES AND TRAFFIC”, ARTICLE XVII “SCHEDULES”, SECTION 203-47 “SCHEDULE VIII: STOP INTERSECTIONS”

WHEREAS, the Township of Washington Code sets forth the regulations regarding traffic flow and regulation throughout the Township; and

WHEREAS, the Township Police Department and Township Engineer have recommended that four (4) way stop signs be installed at the intersection of Old Farmers and East Valley Brook; and

WHEREAS, the Township Committee has reviewed the recommendations and is in agreement with same.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Washington, County of Morris, State of New Jersey, as follows:

SECTION ONE. Chapter 203 “Vehicles and Traffic”, Article V “Schedules”, Section 203-47 “Schedule VIII: Stop Intersections” shall be amended to add the following language, with all remaining provisions of this Chapter unchanged.

Old Farmers Road and East Valley Brook Road: Stop signs shall be installed on both sides of East Valley Brook Road.

SECTION TWO. Chapter 203 “Vehicles and Traffic”, Article V “Schedules”, Section 203-46 “Schedule VII: Through Streets” shall be amended to delete the following language:

Old Farmers Road and East Valley Brook Road: Stop signs shall be installed on both sides of East Valley Brook Road.

SECTION THREE. RENUMBERING. This Ordinance may be renumbered for codification purposes.

SECTION FOUR. SEVERABILITY. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

SECTION FIVE. REPEALER. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.
